Supreme Court tosses out part of medical malpractice law

Saying that liability reform changes approved by lawmakers "have gashed Florida's constitutional right to privacy,"

the Florida Supreme Court recently rejected parts of a controversial 2013 medical-malpractice law. In a 4-3 decision, Justices said the 2013 law - which involved an issue known as "ex parte" communications between doctors and defense attorneys - could lead to the disclosure of patients' private health information that is unrelated to malpractice cases. The ruling overturned a decision by the 1st District Court of Appeal in which a widow contemplated

filing a medical-malpractice lawsuit against her deceased husband's physician. As part of the ruling, Justices wrote that they were making clear that the privacy rights of people who have died are protected. (News Service of Florida, Nov. 9, 2017)

Medical malpractice records battle brews

The Constitution Revision Commission, which meets every 20 years, can put proposed constitutional changes directly on the 2018 ballot. A former general counsel to Gov. Rick Scott filed a proposal that would amend the state Constitution to place limits on what types of records could be used in lawsuits filed against doctors, hospitals and other health-care providers. Voters in 2004 approved

a constitutional amendment that gave patients the right to access records in adverse incidents. The proposal would make it clear that access to adverse medical-incident reports does not “abrogate attorney-client communications or work product privileges for patients, health care providers, or health care facilities.” (News Service of Florida, Nov. 28, 2017)

Senate moves again on prior authorization, fail first

Senate Bill 98 amends current law to require health insurers, HMOs, Medicaid managed-care plans and pharmacy benefit managers to approve or deny prior-authorization requests in urgent circumstances within 24 hours of receiving the requests. In non-urgent situations, companies would have three days. The bill also creates a new law to address “step therapy” or “fail first” protocols used by insurance companies, HMOs and pharmacy benefit managers. Bill sponsor Greg Steube, a Sarasota Republican, told senators that if they would like to see the proposal make it into law, they need to press the House of Representatives - which, he said, killed a similar measure last year. (News Service of Florida, Nov. 8, 2017)

Panel eyes health cost transparency, certificate of need restrictions
(News Service of Florida, Nov. 25, 2017)

Constitution Revision Commissioner Frank Kruppenbacher has proposed an amendment that, if approved by voters, would require the Legislature to guarantee patients “transparency in health care.” That transparency would apply to such things as medical costs and information needed to help patients make informed decisions about treatment. Kruppenbacher offered another health care proposal that would eliminate “certificate of need” laws.

Lawmakers consider expanding patient safety disclosure mandates
House Bill 35 would require a series of measurements of patient safety. The legislation’s sponsor says the state-developed surveys would differ from national ones because they would contain questions about where staff seeks care and make the information publicly available. The annual survey also would measure issues such as the frequency of adverse events, comfort levels in reporting potential problems or errors and staff perceptions about the support of facilities for patient safety. The bill is ready to go straight to the full House for consideration after the start of the 2018 session in January. (News Service of Florida, Nov. 15, 2017)

Senators back overnight stays at surgery centers

Ambulatory surgical centers could treat patients overnight under a bill approved unanimously by the Senate Health Policy Committee. The Senate bill is similar to a House version, which is ready to go to the House floor after the 2018 legislative session starts next month. The House bill doesn’t include the restrictions on providing health care to children and would allow so-called “recovery care centers.” (News Service of Florida, Dec. 6, 2017)

Rural medical programs may add new location

Florida State University’s rural based medical program may add a new location in Citrus County. The Director of Rural Medical Education says he hopes Citrus Springs can provide opportunities for students to learn about several specialties at a time. Through FSU’s rural-based program, third and fourth year students learn how to treat patients in underserved and minority areas. (WFSU, Oct. 23, 2017)
