

MESSAGE FROM THE PRESIDENT

As I attended meetings this year representing the Florida Urological Society (FUS), the Southeastern Section of the American Urological Association (SESAUA) and the American Association of Clinical Urologists (AACU), I came to the realization that the FUS is an exceptional state urological society. We are large, collaborative, and forward thinking in ways that many organizations yearn to be.

First some basic facts about the urology work force in the United States according to the AUA's 2018 census:

- There are 12,660 urologists in the United States with 10,693 who are actively practicing for at least 25 hours per week.
- Florida has 3rd most urologists with 882 actively practicing – behind only California and New York.
- We have 4.2 urologists per 100,000 with the average in the US being 3.89 per 100,000.

One of our unique strengths as a state society is how cohesive the FUS community is. We have participation from all state academic centers and great support from private and employed urologists working together. This is the reason why we have a great yearly meeting with an awesome scientific session every year. We have also become more active in medicine advocacy - particularly with regard to urology. In a collaborative effort with the SESAUA and the AACU at the national level, we keep a close watch on activity in Tallahassee that could affect the practice of urology, and we are also teaming up with the Florida Medical Association (FMA) and Florida chapter of the American College of Surgeons (ACS) in our advocacy efforts in Tallahassee.

We also support the future generations of urologists by supporting urology residents through the pyelogram conference and the resident debates at the FUS Annual Meeting. We have also supported four residents from four different programs to attend the Annual AUA Advocacy Conference in Washington, DC in March. No other state society has done as much. This has been very positively received by the residents who have attended, and they have begun to realize the importance of advocacy. We will continue these efforts and will support residents to attend the AACU's upcoming Annual Meeting this October in Washington, DC. We hope that from among those residents attending these meetings will emerge the future leaders of urology.

Based on previous years' survey results, our annual scientific session content is designed to meet the needs of the practicing urologist. This year is no exception. This year's Program Committee Chairs, Dr. Paul Crispen and Dr. Larry Yeung, from University of Florida, have put together a fantastic program all attendees should be able to appreciate. Dr. Sijo Parekattil, Chair of Scientific Program for Allied Health will also put on a good program. So I encourage and invite all 882 urologists in Florida to join us at the Hyatt Regency Grand Cypress in Orlando for our 71st Annual Meeting. There will be good networking, learning, and it's a great venue for the whole family as well. I look forward to seeing you all in person this Labor Day weekend at Hyatt Regency Grand Cypress in Orlando.

NEWS FROM THE FLORIDA MEDICAL ASSOCIATION

The 2019 Florida legislative session, which started on March 5, is set to end on May 3, 2019. As of writing of this update in late April 2019, the Florida Medical Association and organized medicine appear to be on track for several major legislative victories. Former Gov. Jeb Bush considered one his major policy victories the 2003 cap on non-economic damages in medical malpractice suits (limits on pain and suffering awards to \$500,000, or \$1 million for catastrophic injuries). Unfortunately in a 4-3 decision, these

caps were declared unconstitutional by the Florida Supreme Court in June 2017. Of the four justices who voted to find the cap unconstitutional, three reached mandatory retirement in January 2019. With the election of a pro-medicine governor, they have been replaced by justices more favorable to caps. Governor Ron Desantis has also indicated that he may revisit the issue of tort reform during his term in office.

At the start of the legislative session, Gov. DeSantis, accompanied by Speaker of the Florida House Jose Oliva and Agency for Health Care Administration Secretary Mary Mayhew, announced his support of Canadian drug importation programs while making an appearance in The Villages, FL. On April 11, the House voted overwhelmingly to pass HB19 a bill which would establish two programs to import FDA-approved prescription drugs into the state. A Senate version (SB 1528) cleared the Senate Health and Human Services Appropriations Subcommittee on April 18 and is headed for the full Senate where is it expected to pass.

The Department of Health and Human Services HHS and the federal government would have to approve this program before it could be implemented.

The FMA has opposed repeated attempts to expand the scope of practice for mid-level providers. The Florida House passed legislation (HB 821) on April 17 filed by Rep. Cary Pigman, an Avon Park ER physician that would allow the independent practice of ARNPs. This has also been a priority for House Speaker Jose Oliva. Fortunately, this legislation is opposed by Governor Desantis. The Florida Senate has not considered its version of ARNP independent practice legislation (SB 972) and the 60-day legislative session will likely to end on May 3 without the senate bill obtaining a hearing.

Repeal of Certificate of Need (CON) laws has been a priority of the FMA. Despite support from the previous Governor Rick Scott, strong opposition from hospital lobbies prevented passage. CON law repeal, telehealth and prescription-drug importation programs have all been high priority issues of both House Speaker Jose Oliva and Governor Ron Desantis. The Florida House passed HB 21 on March 21, 2019 that would eliminate certificate of need programs for hospitals, nursing homes and hospices. A companion bill (SB 1712) is now under consideration in the Senate with revisions and is expected to pass. The bill's sponsor is Senate Health Policy Chairwoman Gayle Harrell, a Stuart Republican and a staunch supporter of the FMA.

Legislation priorities that did not pass in this session though remain on the FMA's agenda include bills requiring health insurers to expedite step therapy exception requests, legislation to prohibit retroactive denials by insurance companies and termination of Maintenance of Certification Mandates.

Governor Signs Drug Importation Plan

Gov. Ron DeSantis signed into law June 11 a measure that gives the state the go-ahead to pursue approval to import prescription drugs from Canada and other countries. But the Republican governor acknowledges that the program cannot launch until it receives approval from federal authorities. The new law would allow Florida to establish Canadian and international drug-importation programs.

The Canadian program would be under the auspices of the state Agency for Health Care Administration and the second program, an international drug importation program, would be established under the Department of Business and Professional Regulation. (News Service of Florida)

"Patient Savings Act" Becomes Law

Gov. DeSantis on June 12 signed the Patient Savings Act. The new law will give patients information about the costs of health procedures and services, as well as potentially reduced premiums when they shop for lower-cost options. The act covers clinical laboratory services, infusion therapy, inpatient and outpatient surgical procedures, and obstetrical and gynecological services. It also covers inpatient and outpatient nonsurgical diagnostic tests and procedures, physical and occupational therapy services, radiology and imaging services, prescription drugs, and telehealth services. Legislature Passes New Telehealth Law

On April 29, 2019, the Florida State Legislature passed HB 23, a law providing guidelines on the use of telehealth, with an effective date of January 1, 2020. The new law authorizes out-of-state health care professionals, without a Florida license, to use telehealth to deliver health care services to Florida patients if they register with the Department of Health or the applicable board, meet certain eligibility requirements, and pay a fee. 24-Hour Stay at ASCs Approved, Hospital CON Repealed

As things stand now, patients admitted to an ambulatory surgery center (ASC) in Florida must be discharged the same working day. No overnight stays are allowed. Under HB 843, passed without a dissenting vote in either the House or Senate, Floridians would be able to stay in an ASC for up to 24 hours. That would increase the number and types of surgeries that could be performed at the centers. Also during the 2019 legislative session, advocates secured repeal of restrictions on new hospital construction in Florida. House Bill 21 would end the state's Certificate of Need (or CON) review of general hospitals. This would also end such oversight of "tertiary hospital services," including new neonatal intensive care units and organ transplant centers, starting July 1. (Naples News, Fort Myers News-Press)

Medical Records Debate Re-Emerges

Nearly 15 years after Florida voters approved a constitutional amendment about access to records in medical-malpractice cases, a Jacksonville hospital has launched a federal lawsuit arguing it should be shielded from being required to turn over documents to a patient. The lawsuit, filed this month in federal court in Jacksonville, is the latest in a series of legal disputes about whether hospitals need to disclose records about patient care as part of malpractice litigation under the 2004 constitutional amendment. The Florida Supreme Court in 2017 issued rulings that broadly interpreted the constitutional amendment to require records to be turned over. In the new case, however, attorneys for UF Health Jacksonville are asking a U.S. district judge to declare that the disputed records are shielded under a federal law that "preempts" the state constitutional amendment. Also, the hospital contends that it could face federal penalties if it is required to turn over the information because of the constitutional amendment. (News Service of Florida)

Medicaid Expansion Plan Passes Key Threshold

A proposed constitutional amendment that would expand eligibility for the Medicaid program has passed a key initial threshold, readying it for review by the Florida Supreme Court. If the Supreme Court signs off, the political committee would need to submit a total of 766,200 signatures to get the Medicaid measure on the November 2020 ballot. The proposed constitutional amendment would expand eligibility to people whose incomes are up to 138 percent of the federal poverty level, an amount that varies depending on the number of people in a family. (News Service of Florida)

CME INFORMATION

ANNUAL MEETING

Educational Needs:

The field of urology covers a broad spectrum of both benign and malignant diseases of the genitourinary system, including the kidneys, ureters, bladder, prostate, urethra and male external genitalia. Clinical research evidence to guide the evidence-based practice of urology continues to evolve rapidly; however outside CME events, urologists have limited opportunity to familiarize themselves with evolving diagnostic and therapeutic approaches to the disease they treat on a day-to-day basis.

The objectives of this meeting are to provide Florida urologists with a convenient opportunity to educate themselves about the state-of-the art management of urological diseases and engage with expert faculty of national prominence. Particular emphasis will be provided via recommendations from evidence-based clinical practice guidelines as well as continued quality improvement in urological patient care. Specific lecture sessions surrounding the detection and treatment of urologic malignancies will update the urologist on the latest technology available to enhance their clinical practice and outcomes. In addition, focused lectures by national experts will address contemporary issues in voiding dysfunction, reconstruction, infertility, BPH and endourology. Such forums provide an opportunity to disseminate novel techniques and technologies in an evidence-based manner to advance the overall field of knowledge.

The overall goal of the meeting is to provide an evidence-based pathway to discuss the current management of patients suffering from urologic diseases.

Educational Objectives:

At the conclusion of the FUS 71st Annual Meeting, attendees will be able to:

- Discuss the role of the adjustable balloon continence system for the treatment of male stress urinary incontinence.
- Discuss the role of Aquablation for the management of BPH/LUTS.

- Discuss patient selection for salvage pelvic lymph node dissection in management of prostate cancer.
- 17. Describe the role of vasectomy in family planning in developing countries and volunteer opportunities via no scalpel vasectomy international.
- 18. Familiarize and learn regarding finances of retirement including current movement of financial independence to retire early (FIRE).
- Describe the history and reasons behind current healthcare cost in the United States and possible solution to the tremendous rise in cost of current health care.
- Explain the pros and cons of maintenance of certification, the existence of alternate boards (national board of physicians and surgeons) and advocacy at the state level.

NURSE PRACTITIONER & PHYSICIAN ASSISTANT CLINICAL & HANDS-ON SESSION

Educational Needs:

With the declining urology physician work force and increasing aging patient population, it is likely that nurse practitioners and physician assistants may play a larger role in the management of difficult urethral catheterization (DUC). There is a paucity of structured hands-on training for nurse practitioners and physician assistants in DUC and this session is geared at meeting those needs and providing a foundation for further on-the job training and application. This session will also provide clinical guidelines for common urological conditions.

Educational Objectives:

At the conclusion of the Nurse Practitioner & Physician Assistant hands-on course, attendees will be able to:

- 1. Describe the normal urethral anatomy and be more comfortable with Foley catheter insertion.
